INFINITO GLOBAL LOGISTICS' PRIVACY POLICY

Infinito Global Logistics ("IGL") respects the privacy of its visitors and customers and understands the importance of privacy to visitors to our website. We collect and store information so that we can efficiently provide information to our users and process your requests for additional information and materials and to process your orders. This privacy statement is designed to help you understand what information we gather and what we do with the information.

Your Information. Personal identifying information, such as your name, street or e-mail address, phone number or any other information which, when used by itself or with other data, might identify a you or your company is only collected if you send it to us voluntarily, as part of using our service, or provide such information in connection with a request for information. We may also use this information to send you notices regarding IGL products and services and to further personalize your experience on our website. Personal identifying information is used only for our legitimate business interests, including the aforementioned notices, to supply requested information, to answer your questions, and to comply with applicable laws and regulations.

Disclosure. By giving IGL your personal identifying information, you grant IGL the right to use this information for reasonable business purposes and in a manner consistent with the policies of IGL and applicable state and federal laws and regulations. We do not sell, rent or disclose your personal identifying information to any third party, except as described in this section. We may contract with reputable vendors to assist us in processing information or delivering the items that you may request. These vendors are restricted from using or selling the information for any purpose other than helping us to provide the materials and requested services. We may provide aggregate statistics about our customers, online traffic patterns and related information to reputable third parties, but these statistics will not include any personally identifying information. Finally, if disclosure of any information is required by law or by an appropriate government authority, we will comply accordingly.

<u>Cookies</u>. As part of offering and improving our services, we may use "cookies" to store and sometimes track information about our online customers and users. A cookie is a small amount of data that is sent to your browser from a web server and stored on your computer's hard drive. Cookies can make use of the web easier by saving status and preferences about a website. Some parts of our website, where you are prompted to log-in or that are customizable, may require that you accept cookies. Cookies by themselves cannot be used to find out the identity of any user. Most browsers are initially set to accept cookies but users can change the setting to refuse cookies or to be alerted when cookies are being sent.

<u>Your Control</u>. You may, at any time, remove your personal identifying information from our database. If you have submitted personal identifying information to IGL, and you wish to have it removed from our records, please e-mail us at (<u>insert appropriate e-mail address</u>). However, for our record keeping purposes, we will retain your personal identifying information if submitted for any previously completed registration on our website.

<u>Your Use</u>. By using this website, you agree not to disrupt or intercept our electronic information posted on this website or on any of our servers. You also agree not to attempt to circumvent any security features of our website, and to abide by all applicable, local, state, federal and international laws.

In the section of our website that allow you to access articles and other materials, we may ask for some personal information, such as name, mailing address and e-mail address, but this information will only be used by IGL to supply these materials to you or contact you, if necessary, to respond to your request for information and to contact you directly to respond to questions, comments or inquiries. We also may use the information to notify



visitors about updates, new products or services. By using this website, you consent to the collection and use of this information by IGL.

Children. IGL strongly believes in protecting the privacy of children online (we define "children" as minors younger than 13). Therefore, IGL will not knowingly collect or use any personal identifiable information from children or knowingly allow children to register with us. Any information that is inadvertently collected from children will be deleted promptly upon discovery. As one measure to ensure that we do not gather personally identifiable information from children, we require that all individuals provide a valid credit card number before completing a purchase. If we learn that we have inadvertently gathered personally identifiable information from children under 13, we shall attempt to notify such child's parent or guardian and erase such information from our records, unless the child's parent or guardian consents to our maintaining such information.

Use of Data We Collect

1. Personally Identifiable Information

IGL always wants to provide you with the best possible shopping experience and fulfill your orders exactly as you've requested. In order to do this, we use your Personally Identifiable Information to allow us to:

- Process and track your order
- Provide the services you request
- Contact you about the status of an order
- Send you catalogs or promotional offers we believe will be of interest to you
- Identify your product and service preferences
- Customize our communications to you
- Provide information concerning product recalls or products you have purchased
- Improve our merchandise selection and customer service

Your email address will not be shared with any third parties. Instructions for unsubscribing from any newsletters, promotions or non-transactional related emails are included in every email.

Non-Personally Identifiable Information

We use the Non-Personally Identifiable Information that we collect from our customers and other visitors in a manner that does not personally identify any individual. We use Non-Personally Identifiable Information to make our website more interesting and useful to you. We also track the pages or documents accessed within our website. This information is collected for systems administration and for analyzing and improving the value of the material available on our website. This Non-Personally Identifiable Information is used to help our advertisers or our site design team, create advertisements our guests might like.

IGL contracts with an outside service that helps us to better understand your use of infinitogl.com. We may place cookies on your computer so we can collect information related to your use of infinitogl.com. This information allows us to refine and improve the site for our customers and other users. We do NOT collect any credit card, user name or password information or any other personally identifiable information nor will we use data that we collect for any other purpose and is contractually required to keep all the information collected for us in strict confidence.



As a visitor to infinitogl.com, you may "opt out" of our collection of data.

Cookies: Like many other commercial sites, our website utilizes standard technologies called "cookies" to collect information about how our website is used. A cookie is a small data text file, that a website stores on your computer's hard drive (if your web browser permits) that can later be retrieved to identify you to us. Cookies are designed to help a website recognize a user's browser as a previous visitor and thus save and remember any preferences that may have been set while the user was browsing the site. A cookie cannot be read by a website other than the one that set the cookie. Cookies can securely store a customer's password, personalize home pages, identify which parts of a site have been visited or keep track of selections, such as those selected in a "shopping cart." For instance, cookies allow us to prepopulate (or fill in) an email field with your email address if you revisit one of our website and place an order. A cookie cannot retrieve any other data from your hard drive, pass on a computer virus, or capture your email address.

We send a cookie to your hard drive when you make an order to record the product name, category of product that you ordered, the amount paid, the order number and any referral codes. No personally identifiable information is recorded. When you click through to our website from a promotional email, our third-party advertising service partner may send a cookie to your hard drive recording your IP address and other related information.

Information We Share with Others

Our Contractors

We contract with other companies (credit card processors, shippers, website developers) to provide certain services to IGL to fulfill orders, and create our website. In some instances, these contractors may have access to personally identifiable information but they are contractually obligated to maintain the confidentiality of the information and to use it only for purposes of carrying out IGL'S business.

These companies are prohibited by contract from using this information for their own marketing purposes or from sharing this information with anyone other than IGL.

Third Parties

From time to time, we make our postal mailing list (names and postal addresses only) available to carefully screened companies whose products we believe will be of interest to you. If you prefer that we do not share any information with these companies, please contact us at the address below.

Your email address is never shared with any third party (except as described above to our contractors who use it ONLY to carry out IGL'S business.)



Disclosure Exceptions

Notwithstanding the above policies, we reserve the right to disclose your personal information to appropriate third parties if we are required to do so by law or we believe that such action is necessary:

- o To comply with legal process such as a search warrant, subpoena or court order;
- o To protect the company's rights and property;
- o To investigate reports of fraud or of users sending material using a false e-mail address or users sending harassing, threatening, or abusive messages;
- o To protect against misuse or unauthorized use of our website; or
- O During emergencies, such as when we believe someone's physical safety is at risk.

When you provide us your email address, we may send you emails necessary to process your order or respond to a request. For example, after you place an order at infinitogl.com, you will receive an email confirmation and in most cases an email with package tracking information. Your email address will be used only to respond to your request or to process your order, and will not be shared with any third parties. Instructions for unsubscribing are included in every email containing promotional material.
